
ABR Dynamic Blend Equity & Volatility Fund (Inv - Inst Classes)

FUND DESCRIPTION AND OBJECTIVES

The ABR Dynamic Blend Equity and Volatility Fund is a sub-fund of MontLake Corrib UCITS Platform ICAV, an Irish collective asset management vehicle constituted as an umbrella fund with segregated liability between sub-funds with registration number C155133. The investment objective of the Fund is to achieve investment returns by investing at least 80% of the NAV in futures listed or traded on one or more recognized markets that provide exposure to US large-cap equity securities including volatility in the US equity markets. The Fund's performance target characteristics are to generate long-term outperformance with reduced swings and drawdowns, by producing:

- Partial equity participation in a bull market
- Outperformance of equities in a bear market
- Significant positive returns in a crisis





IM COMMENTARY

In October, the S&P 500 dropped 0.91%, and volatility increased 16.89% (SPVIXSTR Index). It was the second month in a row of outsized increases in implied volatility compared to the change in the S&P 500 (heading into the U.S. election). As a result, over September and October throughout several reversals in both equities and volatility, the S&P 500 increased 1.21% while volatility also increased 30.28%. It was an unusual dynamic in general, although perhaps understandable in light of the specific circumstance of the upcoming election. The ABR Dynamic Blend Equity and Volatility Fund's systematic model is not susceptible to fear or anxiety, and it ended the month in a low volatility allocation. For the month, the Fund was down 1.58%.
